

# Can lithium iron phosphate batteries be shipped by sea

Are lithium ion batteries safe to ship?

They're commonly used in hearing aids, wristwatches, smoke detectors and key fobs. Both lithium-ion and lithium metal cells and batteries are hazardous to ship, and they're subjected to roughly the same regulatory requirements depending on mode of transport (i.e., ocean vs. air).

Can I ship a lithium battery abroad?

When shipping abroad, lithium batteries must remain inside their associated device. It is not possible to ship lithium batteries separately. Plus, when shipping lithium batteries abroad you must also check the specific rules in the country that you are shipping to. What is the difference between a lithium cell and a lithium battery?

How many lithium batteries can I ship?

You can only send a maximum of 2 lithium batteries (or 4 lithium cells) in a single package. Lithium Ion battery packaging requirements can vary depending on the type or state of the batteries to be shipped. Can I ship damaged /defective lithium batteries? You are not allowed to ship faulty lithium batteries via couriers /post.

What are the shipping requirements for lithium ion batteries?

In addition, lithium-ion cells and batteries shipped by themselves must be shipped at a state of charge not exceeding 30% of their rated capacity. Lithium batteries are dangerous goods, and all of the regulatory requirements must be complied with, as set out in the Lithium Battery Shipping Regulations.

Can I ship a lithium ion battery by air?

For this reason, any battery that is suspected or known to be defective (swelling, corroding or leaking, for example) is not permitted for shipping within the DHL Express network. When you're shipping lithium-ion batteries by air, it's essential to follow specific regulations regarding their state of charge (SoC).

Can You ship lithium batteries in an ocean container?

If the vehicle can be handled in a non-upright position, it must be secured in strong, rigid outer packaging. For many carriers, certain lithium batteries are totally off limits. Container shipping giant MSC recently reminded its customers that it won't ship lithium batteries in an ocean container if they've been used or damaged.
