### What certifications do battery manufacturers need?

The International Organization for Standardization (ISO) provides several standards that can apply to battery manufacturers, including: ISO 9001: Quality management systems. ISO 14001: Environmental management systems. The KC mark is a certification required in South Korea.

#### How does a battery certification process work?

The certification process typically involves several key steps: Preliminary Assessment: Manufacturers assess which certifications are necessary for their products based on market requirements. Testing: Batteries undergo rigorous testing by certified laboratories to ensure compliance with relevant standards.

#### Do you need a digital battery passport?

The regulation lists the required documentation in Annex VIII. LMT batteries, certain industrial batteries, and electric vehicle batteries (including those containing lithium) should come with a digital battery passportwhich provides consumers with online access to specific information concerning the battery.

#### Do batteries need to be CE marked?

Requirements associated with a new CE conformity assessment of batteries are introduced in the Regulation. This means that all batteries,regardless of whether they are used in a product or supplied separately,need to be CE marked according to this regulation.

#### Are all parts applicable for all batteries?

All parts are not applicable for all batteries. Instead,the regulation defines five battery categories depending on how the battery is used. Some requirements are only applicable for some battery categories. Requirements associated with a new CE conformity assessment of batteries are introduced in the Regulation.
