Who must be an approved battery treatment operator (abto)?

You must be an Approved Battery Treatment Operator (ABTO) if you: You must be an Approved Battery Exporter (ABE) if you: Evidence notes are proof of treatment, recycling or export of portable waste batteries by an ABTO or ABE. It's illegal to send waste industrial or vehicle and other automotive batteries for incineration or to landfill.

Where can I register as a batteries producer?

This is where as a batteries producer you can register with your Environment Agencyfor portable batteries and with the Department for Business, Energy & Industrial Strategy (BEIS) for industrial and automotive batteries. How do I collect waste vehicle batteries?

You must tell final holders how they can request the collection of waste vehicle batteries, for example through information on your website. The waste batteries must go to an approved battery treatment operator(ABTO) or an approved battery exporter (ABE) for treatment and recycling.

Do you need an abto to export a battery?

The rules are different for waste portable,industrial and automotive batteries.
