How does the guarantee work?

How do I know if my car battery is under warranty?

The first will be a letter; usually, a P or S. The second two digits will represent the month, the third digit will be the year, and the last digit will indicate the manufacturing plant. For every car battery you buy, make sure you keep the receipt. This label also lets you know if your car battery should be under warranty.
