Which country imports the most solar cells to India?

China's Dominance in Imports: China is the leading supplier of solar cells and modules to India, accounting for a significant portion of India's imports. As of January 2023-24, China accounted for 53% of India's solar cell imports and 63% of solar PV module imports.

How many solar cells did the US import in Q2 2024?

Imports of solar cells increased significantly in Q2 2024, with monthly imports exceeding 1 GW for the first time in May. After only importing 3.6 GW of silicon cells in 2023, U.S. panel assemblers surpassed the 5-GW TRQ in June 2024 when imports hit 5.2 GW for the year.

When will solar module imports be taxable?

Pursuant to the Presidential Proclamation issued on June 6,2022, duties will not be collected on any solar module and cell imports from these four countries until June 2024, as long as the imports are consumed in the U.S. market within six months of the termination of the President's Proclamation.

Can bifacial solar panels come through tariff-free?

But now, the first 12.5 GWof solar cells imported can come through tariff-free. Domestic panel manufacturers Hanwha Qcells, First Solar, Heliene, Suniva, Silfab, Crossroads Solar, Mission Solar and Auxin Solar petitioned the government earlier this year to extend the Sec. 201 tariffs and include bifacial panels in the order.

What does the new solar proclamation mean for the solar industry?
