What is customs duty on solar panels?

According to TARIC, customs duty for photosensitive semiconductor devices, including photovoltaic cells whether or not assembled in modules or made up into panels; light-emitting diodes, code 8541409000, is 0%. In the HTS tariff system, the duty for solar cells assembled into modules or made up into panels (code 8541.40.60.15) is also 0%.

Where are solar modules manufactured?

The solar modules are assembled in India,but contain (at least in the case of the modules here in issue) solar cells manufactured in China. Applying the Contested Regulation,HMRC determined that the solar modules originated in China,and calculated anti-dumping duty and countervailing duty accordingly.

Does HMRC pay anti-dumping duty if solar modules originate in India?

Applying the Contested Regulation,HMRC determined that the solar modules originated in China,and calculated anti-dumping duty and countervailing duty accordingly. The Appellant,however,considers that an application of Article 24 would result in the solar modules being deemed to originate in India,so that no such duty is payable.

What is the duty on solar panels?

In the HTS tariff system, the duty for solar cells assembled into modules or made up into panels (code 8541.40.60.15) is also 0%. Such an attractive duty makes it profitable to import photovoltaic modules to both the European Union and the United States.

Should you import solar panels into the European Union?

China is the largest manufacturer of solar panels globally. Customs tariffs for photovoltaic modules from this country are very low. That is why importing them into the European Union may be very beneficial. However, one should keep in mind that such installations must conform to many EU market requirements.

Why should you import solar panels from China?

Both the tariffs and the fact that China is the largest producer of solar panels globally make importing them from this country beneficial. As one can see, the duty rates on solar panels imported from China to the EU are very low, and in this case, they're zero.

In accordance with the President's declaration, no solar cells or modules imported from Cambodia, Malaysia, Thailand, and Vietnam will be subject to new antidumping or countervailing duties during the period of the emergency.
