What information should a capacitor provide on a tax return?

Capacitors should provide evidence that they have the authority to act on the individual's behalf, for example a lasting power of attorney (LPA) document, which can be uploaded as an attachment when submitting the return. The details provided must match the details HMRC holds about that person.
