Can You ship lithium batteries in an ocean container?

If the vehicle can be handled in a non-upright position, it must be secured in strong, rigid outer packaging. For many carriers, certain lithium batteries are totally off limits. Container shipping giant MSC recently reminded its customers that it won't ship lithium batteries in an ocean container if they've been used or damaged.

What are the shipping requirements for lithium ion batteries?

In addition, lithium-ion cells and batteries shipped by themselves must be shipped at a state of charge not exceeding 30% of their rated capacity. Lithium batteries are dangerous goods, and all of the regulatory requirements must be complied with, as set out in the Lithium Battery Shipping Regulations.

How do I ship lithium batteries by air?

A table in the Lithium Battery Shipping Regulations manual gives the precise weight of batteries per package on both cargo and passenger aircraft. All marks and labels must be clearly visible on the exterior of all packages and overpacks. Proper marking and labeling is required when shipping lithium batteries by air.

Should lithium batteries be shipped by air?

Regulations for shipping lithium batteries by airare in place to protect everyone who would come in contact with a lithium battery shipment while it is being transported as air cargo; with training being required for everyone in this supply chain,to protect the aircraft, and the people in the aircraft, that is carrying the batteries.

Is lithium battery shipping dangerous?

While classified as a dangerous good, lithium battery shipping takes very specific requirements. that you can find inside the Dangerous Goods Regulations. However, if you only ship lithium batteries you can purchase the Lithium Batteries Shipping Regulations as a standalone manual.

Are lithium-ion batteries a risk to aviation?

There is provision for exceptional updates where an unacceptable riskto aviation has been identified. Due to the high energy density of lithium batteries, usage of lithium-ion batteries is expected to increase elevenfold between 2020 and 2030.
